The Organisation of the Association

ACB Council and Regional Activities

Council and its Executive Committee are responsible for policy, for communication with the Department of Health and NHS Executive and for liaison with a wide range of related bodies in the UK and Europe. Council comprises nine elected Honorary Officers, three National Council members and nine Regional Council members - one elected by each of the geographical Regions of the Association. The chairman of each of the following Committees, Trainees Committee, Immunology Professional Committee, Corporate Members' Executive, the Association's European Officer and a nominee of the Royal College of Pathologists are invited to attend Council meetings to contribute, without voting rights, to policy making and other business.

Scientific Affairs

Scientific activities are at the heart of the Association's work. The Scientific Committee commissions review articles on both clinical and analytical aspects of laboratory medicine, it monitors and advises on standards and quality issues and it helps to promote research and development within the clinical science through a scholarship award scheme.

Clinical Practice Section

The ACB Clinical Practice Section (CPS) was formed in 2005 and is centred around direct clinical care provided by the medical members of the ACB. It works through three divisions: Specialist Interests Division with specialist groups such as Cardiovascular Prevention or Nutrition, the Training Education and Academic Development Division and the Professional Affairs Division.

Education

Education and training are a major concern of the Association and it ensures that every trainee clinical biochemist and immunologist within the NHS receives proper training on approved courses of study. The Education Committee supports the promotion and delivery of training of Clinical Biochemists and Immunologists at all stages of their careers through a co-ordinated programme of training courses, organising and monitoring in-service training (Continuous Professional Development-CPD) through a network of Regional Tutors. The Committee also monitors and co-ordinates manpower planning.

Immunology

Immunologists are represented within the ACB by the Immunology Professional Committee, which meets twice a year and represents immunologists on the various other ACB committees. Clinical Immunologists follow their own training program to obtain registration as a Clinical Scientist in Immunology and take the FRCPath exams in Immunology.

Scientific Meetings

The National Meetings Committee organises the prestigious annual scientific conference and exhibition which is attended by well over 750 delegates. The National Meeting is complimented by an active and varied programme of scientific meetings at Regional level.

Publications

The Publications Committee is responsible for producing the Annals of Clinical Biochemistry (an internationally respected journal) and a colourful monthly 'ACB News' which keeps members and others concerned with science in medicine in touch with current matters of interest.

ACB Venture Publications, a publishing arm of the Association produces a series of books intended to create bridges between Clinical Biochemistry & Medicine and Management & Technology in Laboratory Medicine. Volumes include Therapeutic Drug Monitoring & Laboratory Medicine, Nutrition & Laboratory Medicine, Diabetes & Laboratory Medicine, 'Neonatology and Clinical Biochemistry', and 'Intensive Care and Clinical Biochemistry', as well as major texts on Laboratory Accreditation and Statistics in the Laboratory. Other titles available are 'Primary Care and Laboratory Medicine' and 'The Association of Clinical Biochemists - The First Forty Years'. A selected series of publications from our US sister organisation the American Association for Clinical Chemistry (AACC) is also available at special ACB member's discounted prices.

Trainees

The Trainees Committee represents the interests of the training grades of Clinical Biochemists by facilitating communication and providing feedback on training and other relevant issues.

Professional Affairs

The Federation of Clinical Scientists (FCS) is separate from the activities of Council and its standing committees. It represents ACB members in all trade union activities, is involved in pay negotiation for clinical scientists and provides support to individuals in matters of conditions of service. This service is also available to professionals in other branches of Clinical Science who may not have interests in biochemistry and includes sub-sections for clinical geneticists and microbiologists.

Membership Categories and Subscription Rates

Ordinary Membership (Voting Member)

Persons admitted as Ordinary Members shall be health professional with an interest in Clinical Biochemistry in the UK and Ireland. Admission to membership is at the discretion of Council and the decision of Council is final. Applications for admission to the Association shall be supported by two Ordinary Members of the Association to whom the candidate is personally known. Candidates shall be elected to membership of the Association by Council on advice of its Officers, but Council shall not change the conditions under which members shall be admitted without reference to a General Meeting of members. They shall receive the publications of the Association – ACB News, Annals of Clinical Biochemistry, applicable books published by Venture Publications and be able to attend meetings of the Association at member rates. They shall be eligible for election to Council.

Federation Membership

Persons admitted as Federation Members shall be engaged in the practice of laboratory medicine (other than Clinical Biochemistry since membership of the Federation is included in Ordinary Membership) or allied disciplines in the NHS e.g. microbiology or cytogenetics. They must hold academic qualifications equivalent to those required for Ordinary Membership and wish to be represented by the Federation but for whom wider participation as Members of the Association is inappropriate. They shall receive the ACB News and be able to attend meetings of the Association at member rates. They shall not be eligible for election to Council. The Federation will not normally provide resources in support of a member's industrial relations case where the main substance of the case began before or within 90 days of the date of the written application for membership. At the discretion of the Officers appropriate advice will be offered.

Student Membership

Persons who are undergraduates or wholly grant-supported post graduate research students resident in the United Kingdom and who are not subject to UK income tax may at the discretion of Council be admitted as Student Members. Applications for admission to Student Membership shall be submitted in the same form as that for Ordinary Membership. Written application must be made at the beginning of each calendar year to renew membership with evidence that the applicant is still a student. Student Membership shall cease on 31st December in the year of completion of studies but on gaining permanent employment, the person may, at the discretion of Council, be admitted to Ordinary Membership. They shall receive the publications of the Association and be able to attend meetings of the Association at member rates. They shall not be eligible for election to Council.

Overseas Membership (Voting Member)

Members fulfilling the criteria for Ordinary membership (see above) but working overseas may be elected to membership at the discretion of Council. In addition to the application form and fees they must provide copies of certificates or other proofs of qualifications. They will receive the benefits of Ordinary members.

Subscription Rates (effective from 1 January 2010 to 31 December 2010)

- Members are encouraged to establish a Direct Debit (DD) for subscription payments to ensure uninterrupted continuity of membership benefits in the future. (Only available for UK sterling bank accounts). Otherwise a Sterling cheque drawn on UK bank must accompany the application.
- Ordinary Members paying the lowest subscription rate by DD may elect to pay in two equal instalments (January & July).
- Individuals joining October to December in any year, and paying by DD, will not pay their dues until January of the following year but will receive journals and other benefits immediately. Membership will then extend to the next December.
